The Government of Ghana has *received a loan* and *has requested for additional loan* from the Japan International Cooperation Agency (JICA) towards the cost of the Construction of a New Bridge across the Volta River on the Eastern Corridor Project and intends to apply part of the proceeds towards payments under the contract for the Construction of a New Bridge across the Volta River on the Eastern Corridor Project.
2. The Ministry of Roads and Highway (MRH) acting through Ghana Highway Authority now invites sealed Bids from eligible Bidders for the construction and completion of a continuous cable-stayed bridge of 540 m total length (main span 280 m), with a steel deck edge girder and reinforced concrete pylons; approach roads of 565 m on the right bank and 370 m on the left bank; and associated facilities including a toll plaza and a rest area (“the Works”).
3. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Bidding Document.
